WYOPASS STANDING COMMITTEES

FROM the BYLAWS: Section 1. Permanent Committees. The Association shall have four (4) permanent committees. The members of the committees shall be appointed by the president for one (1) calendar year of service subject to approval of the Board of Directors. The four permanent committees are Legislative, Conference/Continuing Education, Newsletter, and Nomination. The Awards Committee is an ad hoc committee. A Bylaw Committee was appointed in 2008 to improve the bylaws. The Web Site Committee was appointed in 2009.

- a. Legislative: Purpose is to review planning-related legislation proposals; to recommend modification to proposed legislation from the perspective of the professional planner; to provide WYOPASS membership with copies of proposed legislation, recommended modifications, and summarizing analysis of legislation; to poll the WYOPASS membership as to its position concerning proposed legislation; and to keep the membership informed about the process of planning-related bills in the State Legislature. Any policy on Legislative issues shall be set by a majority of returned ballots from the general membership.
