- 184 House Bills and 97 Senate Files considered.—122 have become law

HIGHLIGHTS

LARGE ACRE—SF0011 became law.

- Counties may by resolution apply subdivision regulation for subdivisions between 35 and 140 acres (in addition to existing subdivision regulation under 35 acres).
- The new provisions are described in 18-5-316.
- Exceptions—For any parcel existing July 1, 2008—up to ten (10) parcels of 35 or more acres a may be created without subdivision regulation.
